A miscarriage, also called a spontaneous abortion, is the spontaneous ending of a pregnancy. About one-third to one-half of all pregnancies end in miscarriage before a woman misses a menstrual period or even knows she is pregnant. About 10-20% of women who know they are pregnant will miscarry.
