Define Angling. means fishing with a rod, pole, tipup, handline, or trollboard that has a single line with legal hooks, baits, or lures attached to it, and is held in the hands of, or within sight (not to exceed 100 feet) of, the person fishing.

The bye-law also provides for the use of artificial fly only using single or double barbless hooks upstream of the Railway Bridge Enniscorthy and provides for the use of single barbless hooks and a ban on worms as bait downstream of the Railway Bridge Enniscorthy, Co. Wexford when angling for salmon or sea trout (any size).

Catch and release fishing is increasingly practiced by recreational fishermen.
