Arizona has reciprocity with seven states: Alaska, Colorado, Louisiana, Massachusetts, Minnesota, Missouri and Ohio. To be eligible for reciprocity, your license must be ACTIVE in the reciprocity state, you must have passed the licensing exam in the reciprocity state and you must have practiced chiropractic continuously for three (3) of the last five (5) years.

### Answers Practice Exam Alaska Chiropractic

Alaska Statutes are passed by the Legislature. Regulations (also called the Alaska Administrative Code) are rules adopted by the board to implement, interpret, and make specific the statutes. Both statutes and regulations have the force of law. AS 08.20 and regulations 12 AAC 16 specifically govern the practice of chiropractic.
