Property acquired in a SP state by either H or W before they became domiciled in CA is quasi-CP.

7 Principles of California Community Property

The California legislature defines community property as “all property, real or personal, wherever situated, acquired by a married person during the marriage while domiciled in this state.” Your spouse also owns a one-half interest in your regular income, provided it doesn’t come from your separate property.

Community property unless the deed also specifically designates it as separate property. Depends on source of funds used to acquire property. Community property remains CP unless a written agreement to partition is first executed. Otherwise property is CP with a right of survivorship.

In Alaska, South Dakota, and Tennessee, spouses can opt in to the community property system and/or designate specific assets as community property. In Alaska, spouses can opt in by creating a community property agreement that states all (or some) property and/or income acquired by the spouses during the marriage is considered community property.

California law defines community property as any asset acquired or income earned by a married person while living with a spouse. Separate property is defined as anything acquired by a spouse before the marriage, during the marriage by gift, devise, or bequest, and after the parties separate.
