### LANDLORD-TENANT LITIGATION: UNLAWFUL DETAINER

The court must transfer an unlawful detainer action on its own motion (or on the defendant's motion) if it appears from the complaint or affidavit (or otherwise) that the superior court or court location where the action was commenced is not the proper court or court location for the trial. CCP §396a(b).

An unlawful detainer proceeding is usually initiated by serving the tenant with a 3-day notice to pay rent or quit (CCP §1161(2)-(3)) or a 30- day or 60day - notice of termination of a residential tenancy (CC §§1946, 1946.1).
