Alternatively, a Shareholders' Resolution is used by shareholders in a corporation to propose amendments, decisions, or changes to the corporation at a shareholders' meeting.

This form is most often used by limited liability companies, s-corps, c-corps, and limited liability partnerships. Corporate resolutions are legally binding.

Any officers signing on the corporate entity resolution will have full trading and money movement authorization. If the corporation wants to empower an agent outside the corporation or restrict an officer to trading authorization only, a Limited Trading Authorization form (LTA) must be completed.
