Cosmetology Shop License Requirements A cosmetology establishment is defined as the premises on which cosmetology or 1 or more of its services are rendered or offered to be rendered. Establishments are facilities equipped to perform cosmetology services and are either Full-Service or Limited Service establishments.

Note to LARA
Chapter 1602 of the Texas Occupations Code sets the statutory authority for the regulation of cosmetology in Texas as well as the creation of administrative rules.

Cosmetology School License Requirements. Cosmetology Schools are defined as the premises where cosmetology or 1 or more of its services are taught and must be licensed as such. Licensed schools must provide a full curriculum encompassing all specialties of cosmetological services. Cosmetology schools must comply with all of the following:
