CSU Fee Waiver Program This educational assistance program allows eligible employees to enhance job skills or prepare for a future career by taking classes at any of the 23 CSU campuses, waiving the greater of two courses or 6 units per semester/quarter.

If you have not been approved for an Application Fee ...

Eligible students receive a \$40 transportation fee waiver for unlimited LBT services throughout the semester. If you plan on utilizing this waiver program, please review the eligibility requirements below and refrain from purchasing a pass until your fee waiver application can be processed as no refunds will be provided.

If you do not use the CSU Claim Form, you must provide sufficient information to process the claim and the request must be appropriately signed. Under circumstances where you cannot afford to pay the \$25 fee and you would like to request a fee waiver, you must attach an Affidavit for Waiver of CSU Filing Fee (PDF).

Programs. Employee Fee Waiver Programs provides eligible employees the opportunity to enroll in courses at any California State University (CSU) campus at reduced rates. Courses taken on the fee waiver program must be work-related or part of an individual career development plan.

Eligibility Criteria for Fee Waivers; Mistakes to Avoid; When you apply for admission to the CSU through Cal State Apply you are automatically considered for an application fee waiver based on the information entered in the application. You must fully complete the application before fee waiver eligibility is determined.

With the implementation of Cal State Apply (opens in new window), the payment of the CSU Application Fee no longer occurs at the campus level. Therefore, students (using the employee fee waiver) will be asked to login to their Cal State account and print/scan their payment history to show that the campus application fee was paid.

EXTENDED EDUCATION COURSES DO NOT QUALIFY FOR FEE WAIVER

California State University, Long Beach actively promotes career and professional development for staff employees particularly through the university's Fee Waiver Program. This program, established in 1975, allows eligible staff members to "learn while they earn" and attend classes at CSULB or other CSU campuses for greatly reduced rates.

Application Fee Waiver | CSU

Fee Waivers are authorized by the California Legislature or the CSU Board of Trustees and may reduce the cost of attendance for eligible students. Contact the campus for information on how to apply for a waiver.

Long Beach Transit Fee Waiver | California State ...

The Fee Waiver Program provides a waiver or reduction of certain fees for employees and eligible dependents who enroll in courses at one of the 23 CSU campuses. Admission to a CSU campus is not guaranteed.

Fee waivers are available and can be requested within the application (Common App) or after the application is submitted (CSU Application). (Do I qualify for a fee waiver? As part of Colorado Free Application Day , Colorado residents can apply for free by submitting their application on Oct. 15, 2019.

The late fee will NOT be covered by the fee waiver benefit. It is common practice for an employee or dependent to apply to more than one CSU campus. However, each campus collects an application fee to apply. Under the Fee Waiver Program, only one set of fees is waived at the campus in which the employee/dependent enrolls.

Csu Fee Waiver Guidelines

Applicants who are eligible for the application fee waiver may apply to up to four CSU campuses per application term (i.e., fall, spring). Approved waivers are not transferrable to a future or past application term. Mistakes to Avoid. Be aware that the following common errors may cause an eligible applicant not to receive an application fee waiver:

CSU Fee Waiver and Reduction Program | CSUSB

Fee Waiver. The fee waiver program provides an opportunity for eligible employees to take courses at a CSU campus for career development to attain a credential, undergraduate or graduate degree as part of an approved career development plan and/or to enhance current job-related skills.

File a Claim | CSU

Fee waiver applies to CSU state-supported (general fund) courses only, including state-supported courses that are offered through summer term. Courses in self-support (i.e., Extended Education) programs may not be taken through the CSU Fee Waiver program.

Fee Waiver | California State University Stanislaus

Established by the California Legislature and required by Education Code, CSU campuses must honor these waivers for qualifying students. For more information on a Waiver, please contact your Campus Admissions Office.
