These tasks and procedures must be consistent with the supervising physician's specialty or usual and customary practice and with the patient's health and condition.

IDAPA 22.01.03.037.02(f)(g) requires physician assistants to have a Board-approved supervising physician prior to practice and complete or maintain a current copy of the Board-approved delegation of services agreement as specified by Section 030. Failure to do so is grounds for disciplinary action.
