Program requirements Individuals who are aged, blind, or disabled. If you are age 65 and older, blind, or disabled and meet income and resource requirements*, Washington Apple Health (Medicaid) may provide health care coverage and help pay for Medicare premiums and medical expenses.

Do I qualify? | DSHS

The agency determines income eligibility by comparing countable income as determined of the person's medical assistance unit (MAU), as determined under WAC 182-506-0010 and 182-506-0012, to the applicable income standard. Rules for determining countable income are in chapter 182-509 WAC.

Texas DSHS HIV/STD Program - Ryan White HIV/AIDS Program ...

Policy Statement: A family is considered income eligible when the combined gross monthly base income (earned and unearned) of all family members is at or below the amounts listed below for the corresponding family size. In two-parent families, both incomes must be combined to determine eligibility.

Washington Apple Health (Medicaid) Programs

Eligibility Requirements; Meet the income guidelines. Households with incomes at or below 185 percent of the federal poverty income level are eligible. WIC determines income based on gross income. WIC counts all of the members of a household, related or unrelated. WIC counts an unborn baby as a household member.

WIC Eligibility - Texas Department of State Health Services

(1) If your assistance unit (AU) meets all other eligibility requirements for basic food, your AU must have income at or below the limits in columns B and C of this subsection to get basic food, unless you meet one of the exceptions listed below in subsection (2) of this section.

Washington Medicaid Eligibility: 2019 Income & Asset Limits

For cash assistance, when an AU contains eight or more people we calculate the benefit level by subtracting the countable income from the appropriate payment standard. The grant payment cannot exceed the maximum monthly payment of \$1,026.00. See WAC 388-478-0020 for cash assistance payment standards.

Qualifying When Over the Limits. The income and asset limit for this program is the same as the Regular Medicaid / Aged Blind and Disabled: \$750 / monthly income for a single individual and \$2,000 in assets, and \$1,125 / monthly income for a married couple and \$3,000 in assets.

Eligibility for DSHS Services | DSHS

Basic Food benefits are an additional support to supplement the income that your household spends each month on food. Your benefits are determined using limits set by the federal government. First, we subtract allowable deductions from your income. These deductions include living expenses like rent, mortgage, utilities, childcare and child support.

Eligibility for DSHS Services. Depending on her income and resources she might qualify for family or children's health insurance program. She might also be eligible for Basic Food and Working Connections Childcare. An individual with no children who is temporarily disabled and unable to work might be eligible for General Assistance and Basic Food.

What are the income limits for Basic Food

NOTE: Categorical Eligibility eliminates resource requirements, the gross income test, and net income test for AUs with countable income up to 200% of the federal poverty guidelines. If an AU has income up to this limit, we do not need to look at income limits or resources for Basic Food unless the AU can't be CE because: . A member of the AU is disqualified from Basic Food for an ...

Income - Effect of income on Eligibility and Benefit Level ...

1. If a household has only one source of income, or if all the sources are paid at the same interval, compare the income to the same interval of the WIC income guidelines for the household size. 2. If a household has income sources at more than one interval, annualize all income and compare to the "Annual" column of the income guidelines.

Washington residency: The requirements for food stamps indicate that applicants need to live in the state to collect benefits through the program. Monthly income: Claimants need to earn monthly gross and net income amounts that are within the state's predetermined income threshold.
