Privacy Shield allows for the transfer of personal data from the EU to the US and focuses on the methods of data transfer, including third party transfers. The GDPR is a law that has specific requirements for companies that handle EU data in any country, not just the US. According to GDPR, data transfer may only occur to countries deemed by data protection authorities as having adequate data protection laws. Currently, the US is not generally listed as one of those countries.

The EU-US Privacy Shield was preceded by the International Safe Harbor Privacy Principles. Those were designed between 1998 and 2000 and remained active until October 2015, when the European Court of Justice ruled them invalid on the grounds that they were no longer adequate.

The GDPR establishes a common standard that doesn't exist in the United States. EU data-breach letters must specify the nature of the categories compromised, the number of data subjects affected, the name of the company's data protection officer (DPO), contact information for individuals to learn further information, likely consequences for the data subjects, and measures taken to reduce risk to individuals.

Privacy Shield is an agreement between the EU and US allowing for the transfer of personal data from the EU to US. The GDPR has specific requirements regarding the transfer of data out of the EU. One of these requirements is that the transfer must only happen to countries deemed as having adequate data protection laws. In general the EU does not list the US as one of the countries that meets this requirement.

The EU-US Privacy Shield is a program where participating U.S. companies are considered to have adequate data protection, and can therefore facilitate the transfer of EU data. The EU-US Privacy Shield's predecessor, the Safe Harbor Framework, was overhauled because the EU did not consider this agreement strict enough on data protection for their citizens. The GDPR protects the data of all EU citizens, regardless of whether they currently live in the EU.
