In all other respects the rules prescribed for pleadings for defensive matter are applicable to answers to counterclaims and cross-claims. In other words, when a counterclaim is filed, a general denial is presumed and no answer from the plaintiff/counter-defendant is required—except in certain cases where a verified denial is required under the rules or an affirmative defense is required .
