GRANT PROPOSAL GUIDELINES BY PROGRAM AREA POLICIES GOVERNING SUBMISSION OF PROPOSAL Proposals to the Foundation should set forth the material terms of the grant. A prospective grantee should be prepared to work closely with program staff in revising and refining the proposal before it is finalized.

The Foundation does not make grants to individuals, to religious organizations unless they are engaged in programs benefiting the entire community which would otherwise meet the guidelines stated herein, to political causes or candidates, or to organizations that discriminate on the basis of race, creed, religion, gender, sexual orientation, age, disability, marital status or national origin.

If your organization is a grantee through our National or Cultivating Healthy Communities program – you must show your work's impact through:

Organizations receiving funding for two consecutive calendar years must take one year before re-applying (search our past grants). A final report for any previously awarded grant is required before a new request is considered.
