If you have an FSA, you can access the full amount of your annual contribution on the first day of the plan year. For example, if you elect \$2,000, and on day one you incur \$2,000 of FSA eligible expenses, you can use all of your FSA money to pay for it, even though the money has not fully accrued in the account yet.
