A: Most civil marriages in Korea take place at a local ward office. The embassy assists with marriages of U.S. citizens in Korea by notarizing Affidavits of Eligibility to Marry, a document required by the Korean government; however, no marriage records are kept by our office.

Marriage in South Korea is currently restricted to unions between individuals of the opposite sex as same-sex marriages remain unrecognized. Males over 18 and females over 16 years old may marry with their parents' or guardians' consent, Otherwise South Korea's age of consent to marriage is 20.

Or, you can choose to get married first in South Korea or in another country, and then apply for an immigrant visa with which to enter the U.S.; the equivalent of a green card. If you are a lawful permanent resident, your new Korean spouse becomes a "preference relative," in category F2A.
