Utah law strongly prefers creating a limited guardianship over a full guardianship if at all possible (see Utah Code § 75-5-304). In a limited guardianship, the guardian is only given authority to make decisions for the protect person in specific, limited areas in which that person lacks sufficient capacity or understanding to make decisions.
