Primary hrHPV testing is defined as a stand-alone test for cervical cancer screening without concomitant cytology testing. It may be followed by other tests (like a Pap) for triage. This test specifically identifies HPV 16 and HPV 18, while concurrently detecting 12 other types of high -risk HPVs.

The American Cancer Society recommends that women follow these guidelines to help find cervical cancer early. Following these guidelines can also find pre-cancers, which can be treated to keep cervical cancer from starting. All women should begin cervical cancer testing (screening) at age 21. Women aged 21 to 29, should have a Pap test every 3 ...

Pap Smear After Menopause: How Often to Get a Pap Smear ...

You should stop having cervical cancer screening after age 65 years if you do not have a history of moderate or severe abnormal cervical cells or cervical cancer, and you have had either three negative Pap test results in a row or two negative co-test results in a row within the past 10 years, with the most recent test performed within the past 5 years.

How often do I need a Pap smear? Q-and-A with Margot Watson, M.D., Signature OB/GYN. A Pap smear is used to screen women for cervical cancer. Years ago, women had a Pap smear at each annual visit, but today Pap smears have improved and we know cervical cancer takes many years to develop. Women should start Pap smear screening at age 21.

### Cervical Cancer Screening Guidelines for Average-Risk Women

Guidelines have been developed for cervical cancer screening that address the frequency with which women should have Pap smears. The US Preventive Services Task Force (USPSTF) and the American Cancer Society (ACS) both recommend that all women receive cervical cancer screening every 3 years between the ages of 21 and 65.

Pap tests detect abnormal cervical cells, including precancerous cervical lesions, as well as early cervical cancers. HPV tests detect HPV infections that can cause cervical cell abnormalities. ### Does Medicare Cover Pap Smears?

### New cervical cancer guidelines start making Pap smears ...

If you have an abnormal cervical cancer screening test result, you may need further testing. The following tests may be done depending on your age and your initial Pap test result (see Table 1 ): Repeat Pap test or co-test-A repeat Pap test or a repeat co-test (Pap test and a test for high-risk types of HPV) is recommended as a follow-up to some abnormal test results.

After a total hysterectomy - surgical removal of the uterus including the cervix - ask your doctor if you need to continue having Pap smears. If your hysterectomy was performed for a noncancerous condition, such as uterine fibroids, you may be able to discontinue routine Pap smears.

### National Cervical Screening Program: Guidelines for the ...

Doctors generally agree that women can stop routine Pap test screening after age 65 - whether you've had a hysterectomy or not - if you have a history of regular screenings with normal results and if you're not at high risk of cervical cancer. If you're unsure whether you still need Pap tests, discuss with your doctor what's best for you.
