Health care workers who handle hazardous drugs (HDs) are exposed to harmful chemicals that can cause serious health risks (Cowman & Daly, 2017; Randolph, 2012). Careful handling of HDs is required to minimize adverse health effects of exposure and reduce contamination of the workplace (Oncology Nursing Society, 2018). HDs include those used for cancer therapy (carcinogen, genotoxin, teratogen ...

USP's general chapter 800 ("Hazardous Drugs—Handling in Healthcare Settings" published 2/1/2016 in USP 39-NF 34, First Supplement) cautions that both clinical and nonclinical personnel may be exposed to HDs when they create or use aerosols, generate dust, clean up spills, or touch contaminated surfaces during the receipt, preparation, administration, cleaning, or disposal of HDs (USP 800, 2016).

<800> Hazardous Drugs—Handling in Healthcare Settings Type ...

A third draft document, Managing Hazardous Drug Exposures: Information for Healthcare Settings, is intended to help employers establish workplace-specific management procedures for hazardous drugs. Sixteen drugs have been added to NIOSH ' s 2020 list, including three for which the manufacturers have provided special handling information.

Protecting Health Care Workers: Handling Hazardous Drugs

An important new development related to the safe handling of hazardous drugs is the new U.S. Pharmacopeial Convention (USP) Chapter, Hazardous Drugs-Handling in Healthcare Settings, which is currently out for public comment. Chapter <800> will supersede the hazardous drug section in USP Chapter <797>.
