Insert page numbers justified to the right-hand side of the APA format paper (do not put p. or pg. in front of the page numbers). For the title of the paper, on the APA format title page only, include the words "Running Head" before your title in capital letters. Then type "TITLE OF YOUR PAPER" justified to the left using all capital letters.

APA formatting rules for your paper

Step 1, Set the basic layout parameters. An APA style paper should use a 12 point font size and be double spaced throughout. One inch margins all around are also recommended. Use this basic layout on every page of your paper.[1]Step 2, Dream up a title that's fairly brief. The APA recommends that titles be short but sweet, and to the point. Ten to twelve words is a good length, and the title should give readers a sense of exactly what your paper is about. For instance, a title like "Age ...
