While the eligibility requirements and the subject material of the naturalization test have not changed, applicants are now using a stylus on a digital tablet instead of a paper application. Immigration Services Officers (ISO) will carefully instruct applicants on how to use the tablet before administering the tests:

USCIS officers have authority to conduct the investigation and examination, to include the naturalization interview. The officer should introduce him or herself and explain the purpose of the naturalization examination and place the applicant under oath at the start of the interview.
