The EU is the second-largest destination for Indian exports (over 14% of the total) after the USA. India is the EU's 10th largest trading partner, accounting for 1.9% of EU total trade in goods in 2019, well behind the USA (15.2%), China (13.8%) and the UK (12.6%). Trade in goods between the EU and India increased by 72% in the last decade.

What Countries Are in the European Union?

The trade in goods balance between the EU Member States and India is shown in Table 1c. It shows that nine Member States had a trade surplus with India. The largest surplus was held by Germany (EUR 4 398 million), followed by Belgium (EUR 2 076 million) and Sweden (EUR 523 million). There were 18 Member States that had a trade deficit with India.
