The terms 'documented procedure' and 'record' used in ISO 9001:2008 have both been replaced throughout ISO 9001:2015 by the term 'information'. This is defined as information that is required to be controlled and maintained by an organization, though it is up to each organization to determine the level and type of documentation necessary to control its own QMS.
