21. Labour Relations and Human Resources Management

Labor matters in the UAE are regulated by Federal Law No. 8 of 1980, or the "Law," amended by Federal Laws No. 24 of 1981, No.15 of 1985 and No.12 of 1986. Federal Law No. 8 of 1980, ratified 20 April 1980, defines the minimum standards of rights and benefits for employees to which employers must adhere, as well as the obligations of employees working within the UAE.

If effective enforcement of the law is afforded through a labour inspectorate, collective bargaining can pick up where the law leaves off. If, however, the state infrastructure for having rights vindicated or for assisting in the resolution of disputes that emerge between employers and workers is weak, they will be left more to their own devices to develop alternative institutions or arrangements.

Overview - Qatar Labor Law

Any recruiter of foreign employees who contravenes the provisions of Article (20) and the decisions which organise labour permits and their conditions, will be punished by imprisonment for a period not exceeding one month and a fine not exceeding RO 200 or by one of these two penalties both in addition to the cancellation of the labour permit or its suspension for a period not exceeding one year.
