Individuals who terminate a Medicare supplement policy within 30 days of the annual policy anniversary date may obtain the same plan with no health questions asked for a period of 63 days after the termination of their existing policy, from any issuer that offers that plan. This would include Medicare supplement and SELECT plans.

You may be concerned about medical underwriting when applying for a new Medicare Supplement insurance plan. Medical underwriting is a process in which insurance companies collect detailed information about your health and medical history.

MEDICARE SUPPLEMENT UNDERWRITING GUIDELINES

When a Medicare supplement policy has lapsed and it is within 150 days of the last paid to date, coverage may be reinstated, based upon meeting the underwriting requirements. When a Medicare supplement policy has lapsed and it is more than 150 days beyond the last paid to date, the coverage cannot be reinstated.
