Out-of-Area Waiver If your vehicle is registered in an emissions testing-required city or county, is still located within the state of Missouri , but is/will be outside of its registered city or county for at least 24 months or more, you may qualify for an emissions exemption by submitting an Out-of-Area Waiver Request (Form MO MO 780-2202).

Establishing Financial Responsibility. Under CVC §16021, financial responsibility is established if the driver or owner:. Holds a DMV-issued certificate of self-insurance, per CVC §16052.; Is covered as an insured or principal under a form of liability insurance policy or surety bond per CVC §16054, which covers the driver for the vehicle involved in the accident.
