A Model United Nations resolution will start with a title of sorts, identifying it as a "Draft Resolution" and it will specify which revision it is. The top section, under the "Draft Resolution" will contain the following, each on separate lines:

A resolution is a document that contains all the issues that the committee wants to solve and the proposed solutions to that issue. It's called a resolution because that's what the United Nations calls the documents they produce (here are some real UN General Assembly resolutions). Technically, the resolution should be called a draft resolution before it is voted upon and then called a resolution after it is successfully passed during voting bloc.

Resolutions, which are drafted by delegates and voted on by the committee, normally require a simple majority to pass (except in the Security Council). Only Security Council resolutions can compel nations to take action. All other UN bodies use resolutions to make recommendations or suggestions for future action.
