The NYC Noise Code is established in Local Law 113 of 2005. In addition, the code was amended by the NYC council in May 2018, lowering the allowed noise levels for after-hours and weekends. The noise limit within 200 feet of a residence is currently 85 decibels, but it will be reduced to 80 dB in 2019 and 75 dB in 2020.
