How Can I Get WIC? Do I qualify? To qualify for WIC, you must meet income guidelines (PDF) and be in any of the categories below: A pregnant woman; A woman breastfeeding a baby under 1 year of age; A woman who had a baby or was pregnant in the past 6 months

The state agency's income standard must be between 100 percent of the federal poverty guidelines (issued each year by the Department of Health and Human Services), but cannot be more than 185 percent of the federal poverty income guidelines.

Applicants for the NYS WIC Program must be: A pregnant woman; An infant or child up to 5 years old; A mother of an infant up to 6 months old; or; A breastfeeding mother with an infant up to 12 months old. A father or caretaker applying for their children. 2. Residential. Applicants must be a resident of New York State.

New York WIC Income Guidelines

The WIC staff uses this to determine if you are income eligible for NY WIC benefits. In some situations, you may be automatically income eligible if you or a family member is currently receiving benefits from other state programs including SNAP (Food stamps), TANF or Medicaid. WIC Program - Suffolk County, New York

WIC provides free healthy food and services to low-income women and children, including nutrition counseling, breastfeeding support, health education, and referrals. Starting February 2019, NYS WIC participants can buy food using an Electronic Benefits Transfer card called eWIC .

Receives income once a month. Annual: Total income for 1 year. 1. How Can I Get WIC?

**New Jersey WIC Income Eligibility Guidelines (Effective: July 1, 2019 to June 30, 2020)
Participation in the WIC Program is limited to those persons whose gross income (i.e., income before deductions for income taxes, Social Security taxes, insurance premiums, bonds, etc.) is equal to or less than the income poverty guidelines increased by 185%.**
