Regular HEAP is a one time benefit from July 1 – March 31 processed directly by the State of Ohio to assist with heating costs. Qualifications: total household income at or below 175% of the federal poverty guidelines.

### **Pip Guidelines Ohio**

The Percentage of Income Payment Plan (PIPP) helps eligible Ohioans manage their energy bills year- round. Payments are based on a percentage of household income and are consistent year-round. If your home is heated with gas, you will have a monthly payment of 6% of your household income for your natural gas bill, and 6% of your household income for your electric bill.
