Form 2555: This form allows an exclusion of up to \$100,800 of your foreign earned income if you are a U.S. citizen or a U.S. resident alien living and working in a foreign country. All foreign earned income (for the individual taxpayer) should be combined on to one Form 2555.

Next to the amount, enter "Form 2555." On Schedule 1 (Form 1040 or 1040-SR), subtract this amount from your additional income to arrive at the amount reported on Schedule 1 (Form 1040 or 1040-SR), line 9 .

Form 2555 is a three-page form with nine sections, each addressing different aspects of the FEIE. Form 2555-EZ, on the other hand, is only two pages and four parts and is comparatively simple.
