(The Small Estates Petition) When an individual passes away in Pennsylvania, the majority of estates are administered through the formal probate process. This process involves appearing before and opening a formal probate file at the Register of Wills, and the personal representative is granted formal Letters Testamentary or Letters of Administration (depending on whether)

Small Estate Affidavit Philadelphia

The Pennsylvania small estate affidavit is for use when a decedent has died with \$50,000 or less value in personal property assets excluding real estate. It can only be used 60 days after a decedent has passed away and it may only be used by the first successor, whether it be a spouse, or a child, if there is not spouse, or a parent.

For small estate affidavits to transfer real property in California the limit increased to \$55,425 from \$50,000. See California Probate Code section 13200. Now Californians can avoid probate if the decedent's total estate does not exceed the new limit of \$166,250.

In Pennsylvania, small estate affidavits are governed under Title 20, Chapter 31, § 3102. The state allows successors of a deceased loved one to file a small estate affidavit for any real estate property not divided among heirs in a last will and testament.

Small Estate procedures may generally be used regardless of whether there was a Will. In general, the two forms of small estate procedures are recognized: 1.Small Estate Affidavit -Some States allow an affidavit to be executed by the spouse and/or heirs of the deceased and present the affidavit to the holder of property such as a bank to obtain property of the deceased.
