O Requires applicants to pass a jurisprudence exam as a condition of licensure. O Removes exemptions from the Social Work Act for non-Texas residents to practice without temporary licensure. O Requires the Board to base delinquent license renewal fees on the normally required renewal fee unless the Board determines that the fees would not cover ...
