The common law police power to conduct a “safety and evidence search” following arrest includes the power to require a person to remove their clothing, if the circumstances require it. However, searches involving the removal of underwear should be rare (see DPP v Tupper [2018] VSC 285).

The Fourth Amendment to the U.S. Constitution protects citizens and criminal suspects from unreasonable searches of their property and persons, and prohibits police officers from making unlawful arrests ("seizures").

Unlawful or invalid arrests may have a variety of important legal consequences. For instance, it is generally recognized that a search of the person arrested and of the immediate premises is valid when “incident” to a lawful arrest. But if the arrest is unlawful, the search is also invalid, and can be barred from the criminal proceedings.
