Printable Virginia Form 760 - Individual Income Tax Return

Married couples filing jointly on Form 760 may reduce their tax by up to \$259 with the STA if each spouse received income during the taxable year. Joint taxable income must be over \$3,000 and both parties must have taxable income to benefit from this adjustment.
