**The main purpose of tax credits is to help families on lower pay make ends meet. Tax credits are also intended to lift families out of welfare dependency and incentivise people to work - before their introduction, most benefits were withdrawn as soon as someone returned to work.**

### **Welfare benefit advice : Mental Health & Money Advice**

**This means, if a social welfare payment is your only source of income you may not pay tax because your tax liability does not exceed your tax credits. The Employee Tax Credit is given to the person claiming the social welfare payment and not to the adult dependant, even if the Increase for a Qualified Adult is paid directly to the dependant.**
